MULTI TASKING STAFF (NON-TECHNICAL) EXAMINATION, 2011
DECLARATION OF RESULT

Staff Selection Commission (Southern Region) published a notice for recruitment to the post of Multi-Tasking (Non-Technical) Staff in Central Government Ministries/Departments/Attached & Subordinate Offices in Andhra Pradesh and Tamil Nadu. The Commission conducted the Multi-Tasking Staff (Non-Technical) Examination on 26/2/2011 & 27/2/2011 and re-examination on 17/04/2011 at various centres all over the country. As the recruitment is done state-wise, the Southern Region of SSC has processed the results pertaining to the states of Andhra Pradesh, Tamil Nadu and Union Territory of Pondicherry. Following are the details of candidates **provisionally qualified** for the posts in the States falling under the jurisdiction of SSC (SR).

List-I: Candidates qualified for the posts in Central Government Ministries/Departments/Attached & Subordinate Offices in **Andhra Pradesh**.

List-II: Candidates qualified for the posts in Central Government Ministries/Departments/Attached & Subordinate Offices in **Tamil Nadu**.

Since no vacancies have been reported till date in Pondicherry, the select list is 'Nil' for this Union Territory.

2. Roll Number, category, etc. of the candidates, as shown in the result, have been taken from their OMR answer scripts. It is important for the candidates belonging to reserved category for whom certain percentage of vacancies is reserved as per the policy of the Government, to note that some of them may have been declared eligible for the specific category mentioned in the result. It is, therefore, in the interest of the candidates concerned to contact immediately this Regional Office in all such cases where they do not belong to the categories shown against their roll numbers.

3. The results are **purely provisional** and subject to the recommended candidates fulfilling all the eligibility conditions prescribed for the post in the Notice of Examination and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings, etc., on the application forms, admission certificates, etc. The candidature of the candidates is liable to be cancelled in case of the candidates found not fulfilling the eligibility conditions or for any other genuine reasons.

4. Candidates may note that as per notice of the examination and instructions given in the answer sheets, they were required to code/write their particulars correctly and sign answer sheets. Such answer sheets which are without signature and where particulars such as name, roll number, ticket number and Test Form number have been written and/or coded incorrectly, have been rejected/awarded ZERO marks.

5. It is proposed to call the candidates for submission and verification of documents, during the period from 12th to 16th September, 2011. The detailed schedule will be placed on the website
